4. Pre-bid meeting shall be held at Barju Rural Municipality Office at 8th June 2026 -12:00 PM
5. Electronic bids must be submitted to the office through PPMO website www.bolpatra.gov.np/egpon or before **12:00 Hrs. on 19th June 2026**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend **at 2:00 PM on 19th June 2026** at the office of Barju Rural Municipality, Amahibelha Sunsari .Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **Nrs. 65,000.00** ,which shall be valid for 30 days beyond the validity period of the bid i.e.**17th Oct. 2026**.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
